#### Brick, Patios & Concrete

#### Preparation

- 1. Dilute as necessary and test on a small concealed area before use.
- 2. Dampen surface with plenty of water.

#### Application

- 1. Apply Cementone Brick & Patio Cleaner with a soft brush or spray.
- 2. If spraying, take care that spray is not blown onto other surfaces.
- 3. Leave for up to 30 minutes then brush stain with a stiff brush. Wash down the area with plenty of water before the product fully dries.
- 4. Repeat procedure if necessary.
- 5. When used on pigmented concrete some colour loss may occur.

#### Terrazzo & Lime Silica Bricks

#### Preparation

- 1. Dilute 1 part Brick & Patio Cleaner to 3 parts water.
- 2. Test on a small concealed area. If there is any indication that the acid is attacking the surface, wash off with plenty of water immediately.
- 3. A weaker solution may be tried. Proceed as above.

#### Mix ratios (by volume)

General Use:	1 parts Patio Cleaner to 2	
	part water	
Severe Staining:	Undiluted	
Terrazzo, Marble, Lime Silica	1 part Patio Cleaner to 3	
Bricks, Limestone:	parts water or weaker	

#### Cleaning

- 1. Clean tools and equipment immediately after use with water.
- 2. Clean at least twice to remove any last residues.

#### **Precautions in Use**

Transport in an upright position, secured from tipping over. Store securely in the boot, not in the passenger compartment. Always store near the ground on a firm flat surface, in a safe position. Take care when using on metal surfaces as the acid may damage them. Always wash off excess thoroughly. The product works by chemical reaction and is often accompanied by 'fizzing'. Washing off the residue is best done soon after the 'fizzing' ceases. When removing spots of lime, limescale or cement it is best to apply the product only where needed.
